

SAGE® Software License Agreement

SOFTWARE PRODUCT: SAGE® Web Access – Levels 1-9

This Software License Agreement (SLA) is a legal agreement between the Licensee and TelcoSolutions, Inc. (TSI) for the TSI software product identified above, which includes access to TSI's SAGE Web site, use of SAGE web-based software at the indicated level and any and all associated media, printed materials, and online or electronic documentation (SOFTWARE PRODUCT). By creating an account on TSI's SAGE Web site, or otherwise using the SOFTWARE PRODUCT, Licensee, its employee, agent or consultant (hereinafter referred to as "Licensee") agree to be bound by the terms of this SLA.

- The SOFTWARE PRODUCT is protected by copyright laws and international copyright treaties, as well as by other intellectual property laws and treaties. The SOFTWARE PRODUCT is licensed, not sold.
- Title to the SOFTWARE PRODUCT licensed to Licensee and all copies thereof are retained by TSI or third parties from whom TSI has obtained a licensing right. Licensee acknowledge and agree that all right, title, and interest in and to the SOFTWARE PRODUCT, including all associated intellectual property rights, are and shall remain with TSI. This SLA does not convey to Licensee an interest in or to the SOFTWARE PRODUCT, but only a limited right of use revocable in accordance with the terms of this SLA.
- The SOFTWARE PRODUCT is licensed as a **single product on a per user basis**. Each user must agree to this SLA and create an account on TSI's SAGE Web site. The user's Internet email address must be his/her official Internet email address.
- Licensee may not resell, or otherwise transfer for value, the SOFTWARE PRODUCT.
- Licensee may not rent, lease or lend the use of the SOFTWARE PRODUCT.
- Licensee may use the SOFTWARE PRODUCT for its purposes only.
- Licensee may permanently transfer all of its rights under this SLA, provided the recipient agrees to the terms of this SLA; and Licensee obtain prior written consent from TSI.

The SOFTWARE PRODUCT is a trade secret or confidential information of TSI or its licensors. Licensee shall take appropriate action to protect the confidentiality of the SOFTWARE PRODUCT. Licensee shall not reverse-engineer, de-compile, or disassemble the SOFTWARE PRODUCT, in whole

or in part. The provisions of this section will survive the termination of this SLA.

LICENSE

TSI grants Licensee a non-exclusive license to use the SOFTWARE PRODUCT at the indicated level:

- Level 1 – Telephone company subpoena compliance office look up by entering a telephone number or company name.
- Level 2 – Telephone company subpoena compliance office look up and generation of a TSI defined subpoena rider by entering a telephone number.
- Level 3 – Telephone company subpoena compliance office look up and generation of a TSI defined subpoena rider by: a) entering a telephone number or; b) by uploading a file containing one (1) to one-thousand (1,000) telephone numbers. Access to the subpoena Log file described in the documentation is disabled. Information written to the subpoena log file is erased daily.
- Level 9 – Full access to the system as described in the then current SAGE User Guide.

SUPPORT SERVICES

TSI may provide Licensee with support services related to the SOFTWARE PRODUCT ("Support Services"). Use of Support Services is governed by the TSI policies and programs described in the user manual, in "online" documentation, and/or in other TSI-provided materials. Any supplemental software code provided to Licensee as part of the Support Services shall be considered part of the SOFTWARE PRODUCT and subject to terms and conditions of this SLA. With respect to technical information Licensee provides to TSI as part of the Support Services, TSI may use such information for its business purposes, including for product support and development. TSI shall not utilize such technical information in a form that identifies its source.

COPYRIGHT

All title and copyrights in and to the SOFTWARE PRODUCT (including but not limited to any images, photographs, animations, video, audio, music, text, and 'applets' incorporated into the SOFTWARE PRODUCT), the accompanying printed materials and any copies of the SOFTWARE PRODUCT are owned by TSI or its suppliers/licensors. The SOFTWARE PRODUCT is protected by copyrights laws and international treaty provisions. Therefore, Licensee must treat the SOFTWARE PRODUCT like any other copyrighted material. Licensee may not copy the printed materials accompanying the SOFTWARE PRODUCT.

U.S. GOVERNMENT RESTRICTED RIGHTS

If Licensee is acquiring the SOFTWARE PRODUCT including accompanying documentation on behalf of the U.S. Government, the following provisions apply. If the SOFTWARE PRODUCT is supplied to the Department of Defense ("DOD"), the SOFTWARE PRODUCT is subject to "Restricted Rights", as that term is defined in the DOD Supplement to the Federal Acquisition Regulations ("DFAR") in paragraph 252.227 7013(c) (1). If the Software is supplied to any unit or agency of the United States Government other than DOD, the Government's rights in the SOFTWARE PRODUCT will be as defined in paragraph 52.227 19(c) (2) of the Federal Acquisition Regulations ("FAR"). Use, duplication, reproduction or disclosure by the Government is subject to such restrictions or successor provisions.

MISCELLANEOUS

This SLA represents the entire agreement concerning the subject matter hereof between the parties and supersedes all prior agreements and representations between them. It may be amended only in writing executed by both parties. This SLA shall be governed by and construed under the laws of the State of Florida as if entirely performed within the State and without regard for conflicts of laws. Should any term of this SLA be declared void or unenforceable by any court of competent jurisdiction, such declaration shall have no effect on the remaining terms hereof. The failure of either party to enforce any rights granted hereunder or to take action against the other party in the event of any breach hereunder shall not be deemed a waiver by that party as to subsequent enforcement of rights or subsequent actions in the event of future breaches.

TERM

This SLA is effective immediately and shall continue for one (1) year. The SLA can be extended for additional years upon payment of the licensing fee then in affect. Without prejudice to any other rights, TSI may terminate this SLA if Licensee fails to comply with the terms and conditions of this SLA.

Limited Warranty Statement

LIMITED WARRANTY

TSI warrants that the SOFTWARE PRODUCT will perform substantially in accordance with the accompanying written materials during the term of the SLA. Some states and jurisdictions do not allow limitations on duration of an implied warranty, so the above limitation may not apply.

NO OTHER WARRANTIES

To the maximum extent permitted by applicable law, TSI and its suppliers/licensors disclaim all other

warranties and conditions, either express or implied, including, but not limited to, implied warranties of merchantability, fitness for a particular purpose, title, and non-infringement, with regard to the SOFTWARE PRODUCT and the provision of or failure to provide Support Services. This Limited Warranty gives Licensee specific legal rights. Licensee may have others, which vary from state/jurisdiction to state/jurisdiction.

LIMITATION OF LIABILITY

To the maximum extent permitted by applicable law, in no event shall TSI or its suppliers/licensors be liable for any damages (including without limitation special, incidental, indirect or consequential) whatsoever (including, without limitation, damages for loss of business profits, business interruption, loss of business information or any other pecuniary loss) arising out of the use of or inability to use the SOFTWARE PRODUCT or the provision of or failure to provide Support Services, even if TSI has been advised of the possibility of such damages. In any case, TSI's entire liability under any provision of this SLA shall be limited to one-quarter (1/4) of the last annual license fee actually paid by Licensee for the SOFTWARE PRODUCT; provided, however, if Licensee have entered into a TSI Support Services Agreement, TSI's entire liability regarding Support Services shall be governed by the terms of that agreement. Because some states and jurisdiction do not allow the exclusion or limitation of liability, the above limitation may not apply.

TSI REMEDIES

TSI's remedies are all remedies available at law and equity.
